150.03—Article VII: Committees, Section C3c: Addition #3: **To provide a representative each year from the committee to the Student Senate. This representative will attend all meetings of the Student Senate, and serve as a liaison to the Faculty Senate regarding issues of concern.*

150.03—Article VI: Faculty Senate, Section A, 13—Change to 14. **Each Chair of a Policy Committee, or a designated representative.*

**130.10 Statement on Diversity
(Introductory paragraph added):**

learning environment where it is safe to explore our differences and celebrate the richness inherent in our pluralistic society.
